These terms and conditions will apply to all contracts between Premier Red Fine Wines Ltd and any buyer.

Any terms of trading outside those set out in this document must be agreed in writing by both Premier Red Fine Wines Ltd and the client.

All prices are based on £GBP excluding duty, VAT & delivery. Foreign currency conversions are given in good faith as guidance only and are seen by Premier Red Fine Wines Ltd as non binding. Only prices that are confirmed on purchase invoices are guaranteed. All wines remain property of Premier Red Fine Wines Ltd until paid for in full.

Premier Red Fine Wines Ltd reserved the right to make changes to prices as a result of fluctuations in currency, duty or VAT.

Account customers must clear the outstanding balance no later than 30 days following the date of invoice.

If the buyer has not opened a credit account in accordance with the terms and conditions of Premier Red Fine Wines Ltd then payment for all orders will be required in full on receipt of invoice prior to products being dispatched.

Should any cost be incurred by Premier Red Fine Wines Ltd due to late payment then these cost will be passed directly on to the buyer.

DELIVERY

Delivery dates quoted are estimates only and the time for the delivery of goods may vary between products.

Premier Red Fine Wines Ltd holds no responsibility for any loss, damages or expenses that may be incurred by the buyer for any delay or failure in delivering goods.

RETURN OF GOODS

No claim for wrong goods, damaged, faulty goods or late delivery of goods shall be made unless Premier Red Fine Wines Ltd is notified in writing quoting the relevant invoice number within 48hours from time of delivery.

Goods will not be accepted for return without prior consent from Premier Red Fine Wines which will be at Premier Red Fine Wines Ltd discretion .

Any goods returned must be in pristine condition fully packed in original packaging.

Premier Red Fine Wines Ltd, if unable to supply goods due to unavailability have the option of cancelling the order and refunding.

Vintage wines can be subject to change. When a vintage changes the next available vintage will be provided.
